Volunteer Agreement

I, the undersigned, volunteer my time and services to assist the Center for New Testament Restoration (CNTR) because of my desire to actively participate in furthering the CNTR's mission. In consideration of the opportunity to participate as a volunteer for the CNTR, I hereby agree to the following terms:

Voluntary Participation

I understand that I am volunteering my services to the CNTR for free as a strictly pro bono endeavor. I am not an employee or independent contractor of the CNTR, nor does this agreement constitute any type of partnership or joint venture. I understand that I will not receive any payments, compensation, or royalties for my services, and I will not be covered by or eligible for unemployment insurance, worker's compensation, social security coverage, retirement plans, health insurance, disability insurance, or other benefits. The CNTR shall have no obligation to provide reimbursements for any equipment, materials, tools, transportation, or other expenses incurred by me.

Confidentiality

I understand that as a volunteer for the CNTR, I may have access to sensitive or confidential information. Except as may be required for the performance of my duties, or unless specifically authorized in writing by the CNTR, I shall not use or disclose any sensitive or confidential information for my or for others' benefit, either during or after my volunteer service, including user contact information, donor lists, financial operations, marketing strategies, and any proprietary information such as computer software, data, algorithms, research, or other trade secrets that have not been publicly released by the CNTR.

Intellectual Property

I hereby irrevocably assign to the CNTR all present and future rights, title, and interest in and to any and all ideas, methods, inventions, designs, software, documentation, utilities, tools, devices, improvements, and any and all deliverables and work product, whether or not copyrightable or patentable, originating with, conceived, invented, acquired or developed, either solely or jointly with others, in connection with my volunteer services. I understand and acknowledge that the CNTR will own all intellectual property rights associated with all works created during the time of the volunteer service and I shall not challenge or take any action inconsistent with such rights. I agree that I will only use the CNTR's intellectual property including letterhead, trademarks, logos, domain name, for official business only when authorized by the CNTR, and I will not use the CNTR's intellectual property for personal communications or personal gain.

Release of Liability

I waive, release, and hold harmless the CNTR and its directors, employees, and other volunteers from any and all claims and liabilities arising from my participation as a volunteer, including, without limitation, claims and liabilities for any injury, illness, death, or loss to my person or property. I and any of my heirs, successors, or legal representatives will not sue the CNTR and its directors, employees, and other volunteers on the basis of these waived and released claims.

Termination

I understand that my volunteer status with the CNTR may be terminated at any time by the CNTR or myself for any reason. The obligations that I have under this agreement shall survive the termination of my volunteer service, regardless of the reasons or method of termination.

General Provisions

I acknowledge that I may not assign, transfer, or delegate any of my rights, duties, or obligations under this agreement or enter into any sub-agreement without prior written consent from the CNTR. This agreement shall be governed by and construed in accordance with the laws of the state of Indiana in the United States of America. This agreement will run in favor of the CNTR and its directors, employees, and other volunteers, and will be binding upon my heirs, successors, and legal representatives. If any provision of this agreement is found to be unenforceable, the other terms will remain effective. I agree that the CNTR shall be entitled to recover from me all attorneys' fees incurred in enforcing the CNTR's rights under this agreement.

I have been given adequate time to fully review this agreement and I understand and acknowledge that by submitting this document I am waiving certain legal rights. By submitting this application, I accept and agree to the terms contained above.
